## When to use this form

Use this form to appeal to a District Court against a decision of the Tenancy Tribunal. You can appeal to the District Court if you think the decision is wrong (based on law).

## **Important Information**

#### When to file

You must file your appeal within 10 working days after the date of the Tenancy Tribunal Order

You can't appeal to the District Court because you don't like the decision. You can't appeal:

- against an interim order
- > a final order for payment of less than \$1000
- a final order to undertake work worth less than \$1000

- You can also print and fill in this form by hand. Use a black pen or blue pen, print clearly IN CAPITALS.
- Answer every question on the form unless the instructions tell you otherwise
