The **Human Rights Commission**:

- looks after the human rights of everyone in Aotearoa New Zealand
- works with Government and communities to make sure that everyone gets their human rights met.




Human rights are rights that belong to every person in the world.









- understands the issues that disabled people face
- understands the issues that tāngata whaikaha Māori face
- has experience in advocacy.



Advocacy means to:

- speak up for someone else or a group of people
- work to get better services / support.







The Treaty of Waitangi / Te Tiriti o
Waitangi is a legal document that
was signed in 1840.

The Treaty / Te Tiriti is about Māori and the New Zealand Government:

- making decisions together
- protecting things that are important to Māori.



The Disability Rights Commissioner also needs to have a good understanding of these laws:

- Human Rights Act 1993
- Crown Entities Act 2004
- New Zealand Bill of Rights 1990.




