Ministry of Justice triennial legal aid review



Background to the review

Purpose

- 1. The Ministry of Justice is currently undertaking a review of the legal aid policy settings (the review). This is the first three-yearly Cabinet-mandated review, with a report to be provided to the Minister of Justice in October 2018. The report must include advice on whether the legal aid policy settings should be adjusted.
- 2. The October deadline ensures any decisions can inform the 2019 Budget process.

Scope

- 3. Minister Little has decided the scope of this year's review will be a targeted regulatory review with narrow legislative changes and a wider access to justice component. The review will focus largely on policy settings in the Legal Services Regulations 2011 and Legal Services (Quality Assurance) Regulations 2011.
- 4. This scope limits what kinds of things we can include in the report and means some issues raised may not be able to be addressed as part of the review. We can, however, signal in the report wider access to justice issues that could form the basis of future work.

Timeframes

- July August 2018: The Ministry is information-gathering, talking to government agencies and
 other stakeholders to inform issues papers and to scope options that will form the basis of the
 report.
- **September October 2018:** The Ministry will develop options and provide the report and a briefing to the Minister of Justice.
- **November 2018 May 2019:** Ministerial decisions and Budget processes. Any resulting regulatory and legislative changes are expected to be implemented through to mid-2020.

Forums with the profession

- 5. We are looking forward to engaging with the profession in forums across the country in August 2018. We would like to hear your views on the issues you are experiencing with legal aid and how these issues could be addressed.
- 6. In particular, we seek your views on the following areas within scope of the review:

Regulatory

- Eligibility for legal aid and the application process
- Legal aid debt and repayment
- Matters relating to contracting and quality assurance of legal aid lawyers

Legislative

- Allowing interim granting in Waitangi Tribunal proceedings
- Allowing deduction notices to be placed on pre-2013 legal aid debt
- Aligning the language used across the Legal Services Act 2011
