COSTS JUDGMENT OF JUDGE J C HOLDEN

(Application for costs on good faith issues and applications for stay of proceedings)

[1] This judgment deals with two applications for costs from Ms Roy: first, in respect of the good faith issue; and second, in respect of Carrington Resort Jade LP's (Carrington) applications for a stay.

- [2] Ms Roy seeks costs of \$1,912 (being for 0.8 days' time at Category 2B) in respect of the good faith issue.
- [3] She seeks \$4,541 for opposing the applications for a stay.³ This is calculated using the Employment Court Guideline Scale for Category 2B, with some adjustments:⁴

- [4] Carrington has not filed any submissions in respect of these applications, despite the Court Registry following up with its agent, Mr Tan.
- [5] The claims for costs are appropriate and are for less than Ms Roy's actual costs. Accordingly, Carrington is ordered to pay Ms Roy a total of \$6,453 for costs on these two matters. Payment is to be made within 28 days of the date of this judgment.
