Updated Legal Aid Outcomes of Budget 2022

I wrote to you on 26 May 2022, regarding government's Budget 22 investment to strengthen the legal aid scheme.

I am now pleased to advise that the 12 per cent increase to hourly rates, which came into effect on 1 July 2022, will also apply to the series of fees available for hearing and waiting time in the fixed fees schedules across all jurisdictions.

These increases will take effect on Monday 3 October 2022, but will apply to all waiting and hearing time claims from 1 July 2022. Historically, changes to fixed fees have only applied to new grants assigned from the date of the change. However, this increase has been applied to all grants, regardless of when they commenced.

As you are aware, there are a significant number of fixed fees for hearing and waiting time across the schedules, and this change has taken considerable effort to implement. While we were unable to implement this any earlier, we will be back paying the difference between the rates paid and the new rates.

Invoices received and paid for, where hearing and waiting time was completed between 1 July 2022 and 2 October 2022, will be processed for payment. Further details on the process for back pay can be found in the attached appendix.

I am also pleased to advise that the Word template package has also been updated to reflect the increase in fixed fees and hourly rates. This will mean that the workaround previously implemented for the hourly rates will no longer be required.

Thank you for your patience as we have worked to introduce these changes. I will be in touch again in November as we look to implement tranche 2 of the budget investment which will be the changes to policy and eligibility settings.

Instructions for Back Pay

You will receive a letter from Legal Aid Services, listing the amount you have been paid on each legal aid file and the difference that you are due to be back paid. To confirm the total amount is correct, you will need to sign this letter and return it to us. Once confirmation is received, your payments will be processed as a disbursement on each relevant legal aid file. If we do require further information from a provider regarding payment, we will make contact in the coming month. These payments will be treated as a priority.
