When to use this form

Use this form in conjunction with a company licence application if you need to add company officers to your company licence. Each additional company officer must complete a copy of this form.

A company officer is a Director, Chief Executive Officer or person(s) occupying an equivalent position.

What you need with your application

To complete your application, you need to send:

• A fully completed form

Completing this form

- Print clearly in CAPITALS
- Use a black pen or blue pen to complete this form
- Answer every question on the form unless the instructions tell you otherwise

Payment information

There is no filing fee with this application.

Application process

In normal circumstances it will take 2 months to hear the outcome of the company application, once all company officers have sent in a company officer form supporting a company licence.

If the company or any of the officers have disqualification criteria, for example criminal convictions, then it will take much longer to determine the outcome.

Important information

If you:

- Provide false or misleading information to the Licensing Authority, you may be liable for a fine of up to \$20,000.
- Work for a licensee, as a Crowd Controller or Repossession Agent without holding a Certificate of Approval you could be fined up to \$20,000.

The Licensing Authority may still grant the company application, but only if the Authority is satisfied that you are suitable to operate as an officer of a licensee in the class or classes of work to which the application relates. Please note that no refund is payable if your application is unsuccessful.
