

Application for review of registrar's decision

When should I use this form?

This form lets you apply for a review of a registrar's decision. Use this form if you are dissatisfied with a registrar's decision that affects you, and you want it to be reviewed. You can apply for a review of a registrar's decision about:

- an attachment order
- an order made following the filing of a financial statement
- a warrant to arrest.

Who can sign this form?

You can only sign this form if you are the applicant. Anyone can help you complete the rest of the form.

How much does it cost to make an application?

The fee is \$250.

How do I file my application?

You must file your application with the court by post or in person. You must also serve a copy of your application on the other party, by post, email or handing a copy to the other party.

You must pay the fee with your application. Complete the payment details on the next page if you are applying by post.

What are the next steps after making an application?

The court will refer the application to a District Court judge for a decision. The judge will consider the application. The judge can confirm, overturn, or modify the registrar's decision.

If you apply in person at a District Court, you can pay by cash or eftpos (Visa or Mastercard credit or debit cards).
