1 What is this form used for?

Use this form to Submit your Annual Return to the Licensing Authority if you hold a current individual licence.

What do you need to complete your Annual Return?

To complete your Annual Return you need to send:

- A fully completed form
- The Disqualification Criteria form, if required
- A fully completed Spreadsheet Details of Certificate Holders, if required
- A cheque totalling the amount of the annual return, if a payment is required. Please see Note 4 for information on the cost of filing an annual return.

Payment Information

- The fee for filing an annual return is determined by the number of certificate of approval holders you employ, or currently contract. The fee is \$30.00 per employee (if any) up to a maximum fee of \$600.00.
