- The fee for the amount of the annual return, if a payment is required. (See below for information on the cost of filing an annual return.)

- You can fill in this form electronically. If you do, you must print, sign, and submit it to the Authority.
- You can also print and fill in this form by hand. Use a black pen or blue pen, and print clearly IN CAPITALS.
- Answer every question on the form unless the instructions tell you otherwise.

The fee for filing an annual return is determined by the number of certificate of approval holders you employ, or currently contract. The fee is \$30.00 per employee (if any) up to a maximum fee of \$600.00.
