Criminal Proceeds (Recovery) Amendment Act 2023: Regulations and Commencement Order

Proposal

- 1 This paper seeks authorisation to submit to the Executive Council:
 - 1.1 the Criminal Proceeds (Recovery) Amendment Regulations 2023 (the **Regulations**); and
 - 1.2 the Criminal Proceeds (Recovery) Amendment Act 2023 Commencement Order 2023 (the **Commencement Order**).

Policy

- The Criminal Proceeds (Recovery) Amendment Act 2023 (the **Act**) passed on 28 March 2023. The Act amended the Criminal Proceeds (Recovery) Act 2009 (**CPRA**), by creating new orders to facilitate the forfeiture of illicit assets:
 - 2.1 new type 2 assets forfeiture orders where a person is associated with an organised criminal group and their readily-available legitimate property is shown to have been insufficient to have acquired the specific property subject to the order; and
 - 2.2 a new disclosure of source order requiring respondents who are overseas to provide information on the source of restrained property within 2 months, or else the court may presume the property was tainted.
- The purpose of CPRA is to deter significant criminal activity, which the new orders do by making it harder to profit from organised and transnational crime.
- 4 Cabinet made relevant policy decisions on 3 May 2021 [CBC-21-MIN-0040; CAB-21-MIN-0138 refers], and 19 April 2022 [CAB-22-MIN-0146 refers]. On 5 September 2022, Cabinet approved the draft Bill for introduction [CAB-22-MIN-0366 refers]. The associated paper noted that regulations were required, and the Act included a delayed commencement to allow regulations to be made.
- No new policy decisions are required, as the Regulations prescribe forms for the new orders created by the Act. Section 173 of CPRA allows regulations to be made by Order in Council. The Regulations also make some minor amendments to existing forms, to reflect the amendments in the Act.

Timing and 28-day rule

The Regulations and the Commencement Order will come into force on 27 July 2023, 28 days following notification in the New Zealand *Gazette*.

Compliance

- 7 The Regulations comply with each of the following:
 - 7.1 the principles of the Treaty of Waitangi;
 - 7.2 advice from the Treaty Provisions Officials Group on any Treaty of Waitangi provisions (not applicable);
 - 7.3 the rights and freedoms contained in the New Zealand Bill of Rights Act 1990 and the Human Rights Act 1993;
 - 7.4 the principles and guidelines set out in the Privacy Act 2020;
 - 7.5 relevant international standards and obligations;
 - 7.6 the Legislation Guidelines (2021 edition).

Regulations Review Committee

There are no grounds for the Regulations Review Committee to draw the Regulations to the attention of the House under Standing Orders.

Certification by Parliamentary Counsel

9 The Regulations were certified by the Parliamentary Counsel Office as being in order for submission to Cabinet.

Impact analysis

- A Regulatory Impact Summary (RIS) was submitted when Cabinet approved the policies for amending CPRA [CAB-21-MIN-0138 refers]. An internal Ministry of Justice quality assurance panel reviewed the RIS and considered the information and analysis **partially met** the quality assurance criteria.
- 11 Cabinet subsequently made refinements to these policies. This second Cabinet Paper was exempt from providing a RIS because the relevant issues had been adequately addressed by the previous regulatory impact analysis, and the revised approach was analysed in the paper itself [CAB-22-MIN-0146 refers].

Publicity

No publicity is planned for the Regulations or Commencement Order. A press statement was published on the Beehive website on 28 March 2023, following passage of the Act.

Consultation

- In developing the Regulations, the Ministry of Justice consulted New Zealand Police, Crown Law Office, and the Ministry of Business, Innovation and Employment (Office of the Official Assignee). The Department of the Prime Minister and Cabinet has been informed.
- In developing the policy for the Act, the Ministry of Justice consulted the above agencies, and also Te Puni Kōkiri, Ministry for Women, New Zealand Customs Service, the Ministry of Foreign Affairs and Trade, the Ministry of Business, Innovation and Employment, the Treasury, and the Inland Revenue Department.

Recommendations

I recommend that the Cabinet Legislation Committee:

- note that on 5 September 2022 Cabinet approved the Criminal Proceeds (Recovery) Amendment Bill for introduction [CAB-22-MIN-0366 refers], which included a delayed commencement to allow regulations to be made prescribing forms for the newly created orders and minor amendments to existing orders;
- 2 **note** that the Criminal Proceeds (Recovery) Amendment Act 2023 passed its third reading on 28 March 2023, and received Royal Assent on 31 March 2023;
- note that the Criminal Proceeds (Recovery) Amendment Regulations 2023 and the Criminal Proceeds (Recovery) Amendment Act 2023 Commencement Order 2023 will give effect to the decision referred to in paragraph 1 above;
- 4 **note** that the Criminal Proceeds (Recovery) Amendment Regulations 2023 and the Criminal Proceeds (Recovery) Amendment Act 2023 Commencement Order 2023 will come into force on 27 July 2023;
- 5 **authorise** the submission to the Executive Council of the Criminal Proceeds (Recovery) Amendment Regulations 2023 and the Criminal Proceeds (Recovery) Amendment Act 2023 Commencement Order 2023.
