## Official Information Act request: Follow up to OIA 100591

Thank you for your email of 20 and 21 December 2022, and 1 March 2023 to the Ministry of Justice (the Ministry), in which you request clarification of our response to your previous OIA request (Our ref: 100591) regarding criminal legal aid providers.

Your request has been referred to me for a response as it falls within my responsibilities as Group Manager, National Service Delivery, and is being managed under the provisions of the Official Information Act 1982.

Firstly, I would like to apologise for the length of time that it has taken to respond to your requests. I will now respond to each part of your request in turn.

- 1. Pursuant to the information received in OIA request OIA100591, I note that the response to question 5 appears to be incomplete. Table 1 of Appendix B only gives the number of PDS lawyers rostered for PDS courts. My question asked for "How many providers are on each individual roster", which means that for a PDS supervised court, the count should include both PDS and non-PDS duty lawyers on that court roster. Please provide that information.
- 2. The duty lawyer question may just be that PDS lawyers don't need to have been approved as duty lawyers to act as duty lawyers at court. I say this because for courts where the PDS has a presence, the total number of PDS lawyers given is 334, but the reply earlier says that just 125 PDS lawyers have approval as duty lawyers. Unless, as noted for private duty lawyers, some PDS lawyers in fact cover more than one court as duty lawyers?

For a Public Defence Service (PDS) Lawyer to act as a Duty Lawyer in court, the PDS Lawyer must hold a Duty Lawyer approval. In response to questions 1 and 2 of your request, please find attached Tables 1 and 2 of Appendix A, including the corrected data for Table 1 as the number provided to you as "Number of Public Defence lawyers rostered for PDS court" was in fact, the number of private lawyers rostered for PDS courts. I apologise for any inconvenience this may have caused.

3. I am also curious how the numbers at Table 2 of Appendix B in OIA100591 were arrived at. I have compared the answers with duty lawyer rosters as displayed on the MOJ website. Just working alphabetically and taking the first few, I note that, by way of example:

Ashburton is said to have eight duty lawyers on the roster but the roster that is shown for that court online has only three.

Blenheim is said to seven duty lawyers but the roster only has six.

Dannevirke is said to have three duty lawyers but the roster for that court has four.

Dargaville is said to have seven duty lawyers but the roster for that court only has five.

Gore is said to have seven duty lawyers but the roster only has five.

Westport is said to have four duty lawyers but the roster only has two.

Masterton is said to have ten duty lawyers but the roster only has six.

Please provide clarification in relation to the above, not limited to each court mentioned above, but in relation to all non-PDS courts where there is a difference in numbers between those on the published roster as at 17 November 2022 and the numbers provided by you.

In response to question 3, the reason why the numbers differ is because lawyers who have taken extended leave during this time have not been included in this number as they are removed from the roster until they have indicated availability to the scheduling team. Rosters for non-PDS courts are determined 2-3 months in advance and for PDS courts, they are determined 16 weeks in advance. Depending on the roster cycle, the number of duty lawyers may differ.

4. Please provide a copy of all internal and external correspondence in relation to OIA100591, including but not limited to any correspondence or advice to ministers.

In response to question 4, please find attached a copy of all internal and external correspondence in relation to OIA 100591. Please note that some information has been withheld under section 9(2)(a) to protect the privacy of natural persons. In accordance with section 9(1) of the Act, I have considered the public interest in making available the information being withheld and determined that it does not outweigh the need to withhold the information at this time.

Happy Friday!!!! I hope you are having a great end of your week. I have just been aware that Tracey Baguley won't be signing more correspondence until the New Year, and I'm trying to make an exception with this one for the following reasons:

- We received this OIA on 4 November 2022, It was allocated on 11 November 2022 and scoped with the relevant business units on the same day. The data for this OIA request was provided only a week before the due date on 29 November 2011. In the middle we have some people involved out of the office with COVID-19 and that caused delays in the relevant sign out process.
