Official Information Act request: Family Trust court proceedings

Thank you for your email of 1 March 2023, in which you requested, under the Official Information Act 1982 (the Act), information regarding the number of court proceedings which involve family trusts over the last 10 years. Specifically, you requested:

"...want to establish how many family trust cases have come before the courts each year, over the last 10 years. I do not want to know the outcomes of those cases, but simply how many of those types of disputes have been issued as court proceedings."

In response to your request, please refer to Table 1 for figures on the number of applications filed under the Trusts Act 2019 for the calendar years from 30 January 2021 to 28 February 2023. Please note the Trusts Act 2019 came into force 30 January 2021 and therefore your request for data prior to 2019 is refused under 18(g)(i) as the information sought is not held by the Ministry and there are no grounds for believing it is held by another agency subject to the Act.

I must advise that any other information regarding cases with proceedings involving family trusts other than those relating to the Trusts Act 2019, is information held by the courts. I am therefore refusing part of your request under section 18(g)(i) as the information sought is not held by the Ministry and there are no grounds for believing it is held by another agency subject to the Act.
