

Official Information Act request: Mental Health interactions

Thank you for your email of 20 April 2023 under the Official Information Act 1982 requesting information regarding mentally/intellectually disabled persons interaction with the justice system. You specifically requested:

- "All reports commissioned and produced by the MOJ with specific regard to, or where the main focus is on mentally ill and/or intellectually disabled people and their interactions with the justice system
- All briefings provided to Ministers about mentally ill and/or intellectually disabled people and their interactions with the justice system
- Any specific reports, briefings, or communications (including internal emails) on the topic of a specialised mental health court"

Your request has been referred to me for response, as it falls within my responsibilities as Group Manager, Commissioning and Service Improvement, and is being managed in accordance with the provisions of the Official Information Act 1982 (the Act).

On 5 May 2023 the Ministry contacted you to clarify your request. You confirmed that your request could be clarified to the following:

- All reports from January 2019 commissioned and produced by the MOJ with specific regard to, or where the main focus is on mentally ill and/or intellectually disabled people and their interactions with the justice system. Please provide a title list of reports and the date of publication. This is not a request for all of the reports in their entirety.
- All briefings provided to Ministers about mentally ill and/or intellectually disabled people and their interactions with the justice system since January 2019. (This may be better requested directly from the Minister?).
- Any specific reports or briefings on the topic of a specialised mental health court since January 2019. The title of any reports produced may also appear in the list requested under part 1 of this request.

In response to your request, I have appended to this letter a list of documents that fall within the scope of your request. Copies of the documents are enclosed. Below you will find the list of documents, appended, and my decisions on their release.

Please note, some information has been withheld from the documents under the following provisions of the Act:

- section 9(2)(a) to protect privacy of natural persons; and
- section 9(2)(f)(iv) to maintain the constitutional conventions that protect confidentiality of advice tendered by Ministers and officials.

In accordance with section 9(1) of the Act, I have considered the public interest in making available the information being withheld and determined that it does not outweigh the need to withhold the information at this time.

In response to part three, I am refusing this part of your request under section 18(d) on the grounds that the information is publicly available. You can find the Mental Health Court evidence brief at: justice.govt.nz/assets/Mental-Health-Courts.pdf

Additionally, information that is publicly available has been refused under section 18(d) of the Act, and links have been provided. Information that has been deemed out of scope of your request has also been excluded.
