- The number of applications made for interim parenting orders in New Zealand?
- The number of applications made for interim parenting orders in Whangārei?
- The average or median time taken by the Family Court to dispose of interim parenting orders in New Zealand?
- The average or median time taken by the Family Court in Whangārei to dispose of interim parenting orders?
- The longest time taken by the Family Court to dispose of an interim parenting order in New Zealand?
- The longest time taken by the Family Court in Whangārei to dispose of an interim parenting order?

On 5 and 10 July 2023, the Ministry of Justice contacted you to clarify the scope of your request. On 10 July you agreed to amend the scope of your request to the following:
