

Official Information Act request: Crimes Act

Thank you for your email of 6 July 2023 to the Ministry of Justice (the Ministry) requesting, under the Official Information Act 1982 (the Act), information regarding charges under the Crimes Act 1961. Specifically, you requested:

Please can you provide me with information setting out the number of charges laid under section 98A of the Crimes Act 1961 (including any that may subsequently be withdrawn) for each year from 2017 to 2022 (inclusive) and the corresponding percentage of successful convictions.

In response to your request, please refer to Table 1, attached. This provides the number of charges and percentage of convictions in relation to section 98A of the Crimes Act 1961, for the calendar years 2017 to 2022.

ELEASE

- The table contains data at charge level, including all charges relating to section 98A of the Crimes Act 1961, which includes the three following offences:
 - 1. 1851: Participates in Criminal Group
 - 2. 1853: Participates in Organised Criminal Group
 - 3. 1859: Other Participation & Associations
- The table contains data from High Court, District Court and Youth Court. However, charge outcomes for youth offenders in the Youth Court are different to adult offenders in the High and District Court. Therefore, the conviction percentage does not relate to the Youth Court.
- This data is based on our latest Tier 1 statistics, released March 2023. Therefore, data for earlier years may have been updated since any previous
 publications. Tier 1 statistics are the key official statistics by which New Zealand's performance as a country is measured. Tier 1 statistics are published
 twice a year in March and September. There are principles and protocols that govern their production and release. More information about Tier 1
