# Official Information Act request: Self-representation cases in courts

Thank you for your email of 21 July 2023, requesting, under the Official Information Act 1982 (the Act) information about self-represented parties in courts. Specifically, you sought:

Active court cases that involved a self-represented party for each year between 2013 and 2023. The year ending at May as was in the previous table is acceptable unless there are more up to date numbers.

- 1. The data required is the total number of active cases for each court type, for each year.
- 2. The number of cases involving a self-represented party for each court type.
- 3. And the percentage of cases involving a self representing party for each court type.
- 4. In addition, could I also please get a gender breakdown of how many individuals were male and female for both the total number of active cases and for cases involving a self representing party as both a number and a percentage.

On 18 August 2023, the Ministry advised you that under section 15(1) of the Act the Ministry had decided to grant your request, but that more time was required to finalise the information for release.

In response to parts 1, 2 and 3, please find attached to this letter a spreadsheet with the information requested. You can filter as you see fit, however this is conditional that you do not change or alter the source data. This has been released to you in full.

Regarding part 4, the Ministry is unable to provide this information as it is not recorded in the Case Management System used by the courts. The Act only applies to information that is already held by the Ministry and there is no obligation to create information in order to respond to a request. Therefore, I am refusing this part of your request under section 18(g)(i) as the Ministry does not hold the information sought and have no grounds for believing it is held by another agency subject to the Act.
