Official Information Act 1982 request: Property Relationships Act 1976

Thank you for your email of 31 July 2023 to the Ministry of Justice (the Ministry), in which you requested under the Official Information Act 1982 (the Act), updated information regarding the Property Relationships Act 1976 (PRA). Specifically, you requested:

Would you please add to this the following two years to 30 June 2022 and 2023 under the respective categories under the various tables retaining the existing annual figures as per attached OIR. Please retain as a landscape document just narrow up the columns to get on the sheets concerned for the various periods.

You have asked to add the last two years data and retain the existing annual figures as those in a previous response (our ref: OIA 90229). I must advise that the Ministry cannot provide the information in this way, as to do so would result in the provision of incorrect data. As previously advised, the data is extracted from a live database that is continually updated, therefore previously supplied information may not match the most recently extracted data.
