


## Official Information Act request: 2022 and 2023 Leaders Forum

Thank you for your email of 9 October 2023 requesting, under the Official Information Act 1982 (the Act), information regarding the Ministry of Justice (the Ministry) leaders' forum. Specifically, you requested:

Could I please request the following information regarding the Ministry of Justice's 'People Leaders Forum' that took place in 2022. Could I please get the requested information for the Ministry of Justice's 'People Leaders Forum' that took place in 2023 too.

- 1. The cost of the forum, including food and recreation and broken down by day and activity if possible.
- 2. The number of attendees
- 3. The content of the forum

The Ministry's 2022 leaders' forum was a one-day online event on 29 November 2022. The content for the first session focused on a refreshed strategy for the Ministry, while the content for the second session focused on employee wellbeing.

The first session was attended by 419 people, and the second session by 388 people. The second session was repeated, for those who had missed it, on 8 December 2022 - a further 55 people attended.

The only invoiced cost for the 2022 leaders' forum was for workshops on wellbeing. These workshops cost a total of \$6,123.25 (GST excluded).

Turning to your request for information relating to the 2023 leaders' forum: this forum followed the publication of the  $Te\ Tah\bar{u}$  o te  $Ture\ |\ Ministry$  of Justice Statement of Intent 2023-2027 in February this year. The forum aimed to connect leaders with the Ministry's purpose, values, and strategic priorities, and explore how the refreshed strategy could be reflected in leadership practice.

The first day was attended by 207 people and the second day by 209 people. For a breakdown of 2023 forum activities, please refer to the table in Appendix 1 attached. The following table provides costs related to this event.
