Official Information Act 1982 request: Drug/alcohol addiction and mental health distress in the Justice system

Thank you for your Official Information Act 1982 (OIA) request of 22 September 2021 to the Ministry of Justice (Ministry). You are seeking information around people who go through the court system with underlying drug and/or alcohol addiction. Specifically, your requested:

I'd be very grateful for any recent data, or research papers, held by the Justice Ministry around the numbers of people who go through the Court system with underlying drug and/or alcohol addiction prior to their incarceration, as well as mental distress/illness (which as you know goes hand-in-hand).

On the same day, you refined your request to the following:

I'm only interested in recent, up-to-date material (say in the last few years) but I don't really want to put a scope of the timeframe for research as sometimes the best/most relevant material can be from 10 years ago for example. I'm basically interested in the revolving door of people getting locked up because of substance abuse/mental health illnesses...so anything around the effectiveness of the Drug Courts would be useful.

In response to your request of any recent data or research papers. We have gathered a list of research data relating to Alcohol and other Drugs and mental health/illness prior to incarceration. As the papers/research are publicly available, I am refusing your OIA request under section 18(d) of the Act. However, links to the documents have been provided under appendix A.
