ELECTORAL AMENDMENT REGULATIONS 2020

Proposal

1. This paper seeks approval to submit the attached Electoral Amendment Regulations 2020 to the Executive Council.

Policy

- 2. On 8 April 2019 Cabinet approved amendments to the Electoral Regulations 1996, and to the Electoral Act 1993. The latter has been implemented through the Electoral Amendment Act 2020.
- 3. Cabinet agreed to amend the Electoral Regulations 1996 to:
 - allow the Electoral Commission to specify a deadline by which overseas postal vote applications must be made
 - allow overseas votes, dictation votes and New Zealand postal votes to be received and processed centrally by the Electoral Commission
 - extend the current deadline for the return of overseas postal votes from four to nine days after election day, and
 - enable the Electoral Commission to provide an emergency special voting service in the event of a localised civil emergency in New Zealand (CAB-19-MIN-0129 refers).
- 4. The attached Electoral Amendment Regulations 2020 implement these four recommendations. These regulations are separate from any amendments to the regulations that may be necessary for the Electoral Commission to deliver the 2020 general election in light of COVID-19.
- 5. This paper does not seek any further policy decisions.

Timing and 28-day rule

6. The proposed regulations will come into force on 27 July 2020. No waiver of the 28-day rule is sought.

Compliance

- 7. The Amendment regulations comply with:
 - the principles of the Treaty of Waitangi
 - the rights and freedoms contained in the New Zealand Bill of Rights Act 1990 or the Human Rights Act 1993
 - the principles and guidelines set out in the Privacy Act 1993
 - relevant international standards and obligations, and

 the Legislation Guidelines (2018 edition), which are maintained by the Legislation Design and Advisory Committee.

Regulations Review Committee

8. There are no grounds on which the Regulations Review Committee should draw the Amendment Regulations to the attention of the House under Standing Order 319.

Certification by Parliamentary Counsel

9. Parliamentary Counsel has certified the Amendment Regulations as being in order for submission to Cabinet.

Impact Analysis

10. The Regulatory Quality Team at the Treasury has determined that the regulatory proposals in this paper are exempt from the requirement to provide a Regulatory Impact Assessment on the basis that they have no or minor impacts on businesses, individuals or not for profit entities.

Publicity

- 11. On 29 July 2019, I issued a media release noting the introduction of the Electoral Amendment Bill to Parliament. This media release noted these amendments to the Electoral Regulations 1996.
- 12. The Ministry of Justice will inform the Electoral Commission of the changes.

Proactive Release

13. I intend to make this Cabinet Paper available to the public at an appropriate time, subject to appropriate redactions, on the Ministry of Justice website.

Consultation

14. The Electoral Commission was consulted on these regulations and this Cabinet Paper. The Department of the Prime Minister and Cabinet was informed.

Recommendations

- 15. I recommend that the Cabinet Legislation Committee:
 - 1. **note** that on 8 April 2019 Cabinet agreed to the following amendments to the Electoral Regulations 1996:
 - allow the Electoral Commission to specify a deadline by which overseas postal vote applications must be made
 - overseas votes, dictation votes and New Zealand postal votes can be received and processed centrally by the Electoral Commission
 - extend the current deadline for the return of overseas postal votes from four to nine days after election day, and
 - enable the Electoral Commission to provide an emergency special voting service in the event of a localised civil emergency in New Zealand.
 - **note** that the attached Electoral Amendment Regulations 2020 give effect to the decisions referred to in recommendation 1 above;

- **3. authorise** the submission to the Executive Council of the Electoral Amendment Regulations 2020; and
- 4. note that the Electoral Amendment Regulations 2020 will come into force on 29 June 2020.
