DECISION ON QUANTUM OF COSTS

Dated 25 June 2012 Adjudicator: S Pezaro [1] On 14 June 2012 I found the claimants liable for an award of costs to the sixth, seventh, eighth and ninth respondents. I directed these respondents to submit a schedule of costs calculated in accordance with the High Court scale of costs for the steps taken from the outset of proceedings to the filing of applications for removal. These schedules were

filed on 22 June 2012.

[2] Although not entitled to do so, the claimants filed a memorandum in opposition on 25 June 2012. I have considered their comments. I am satisfied that given the nature of these proceedings costs calculated on the High Court scale 2B are appropriate. In accordance with High Court Rule 14.2 (f) the costs claimed do not exceed the costs incurred by the parties. I

therefore make the following orders:

[3] Michael James Beazley, Debbie Wai Kapohe, Allene Marie Kapohe and the Public Trust as Trustees for the A.M. Kapohe Family Trust are to pay Alan Graham Thomas Payne and Valerie Payne the sum of

\$7,087.20 immediately.

[4] Michael James Beazley, Debbie Wai Kapohe, Allene Marie Kapohe and the Public Trust as Trustees for the A.M. Kapohe Family Trust

are to pay Ronald Craig Palmer the sum of \$6,749.83 immediately.

[5] Michael James Beazley, Debbie Wai Kapohe, Allene Marie Kapohe and the Public Trust as Trustees for the A.M. Kapohe Family Trust

are to pay Kyle Martin Sutherland the sum of \$9,078.13 immediately.

[6] Michael James Beazley, Debbie Wai Kapohe, Allene Marie Kapohe and the Public Trust as Trustees for the A.M. Kapohe Family Trust

are to pay Metro Realty Limited the sum of \$10,746.00 immediately.
