

This guide is for a registered third party user to assist them with the online service to perform the following:

- Create a Criminal Conviction (CCH) Check request.
- Finalise a request for processing.
- Check the history of a request.



Your administrator will set up your user account.

Once you have received confirmation that your set up is complete, enter you email address and password.



Password FAQs

What are the password requirements?

Your login password must be between 10-64 characters, and have at least four of the following:

- a lowercase letter
- an uppercase letter
- a digit
- a symbol.

How do I reset my login password?


Complete the following steps to reset your login password:

- go to the Criminal Record Check landing page: https://www.criminalrecords.govt.nz/#
- click 'Registered Third Party'
- click 'Forgot Your Password'
- enter the email address that you registered with and click 'Send verification code'
- you will be sent an email with a verification code
- enter the verification code into the login screen service
- enter a new login password and click 'Continue'.

1. Dashboard

1.1 Dashboard

The dashboard is your workspace for the CCH webservice. It helps you manage your request/s before finalisation. This dashboard also displays the various functions that you can perform in the webservice.




1.2 Dashboard headers

The header displays the following functions that a user can perform:

Feature	Description
Dashboard	Allows you to go back to the dashboard.
Create request	Allows you to create a new request for a criminal conviction history.
History	Opens your request history where all your finalised requests are listed.
Clear filters	Clears all filters made from previous searches.
Finalise selected	Allows you to finalise multiple requests at once.

1.3 Dashboard details

2 This section contains a list of requests created that are awaiting further action.



Field	Description		
Applicant name	Name of applicant entered by the user.		
My Reference	User/Organisation can enter a reference for their own purpose.		
Date Created	Date when the request was created.		
Requested by	User that created the request.		
Status	Status of the request.		
	The following statuses can be displayed:		
	 Awaiting Finalisation – awaiting requestor to finalise and submit the request/s. Email Link Sent – email link sent to applicant to complete details. 		
Applicant email	Applicant's email address entered.		
Action	Action/s that can be performed on a request:		
	Cancel – allows you to remove a request from being submitted		



2. Create a request

Use this function to create a new CCH request.



Select Create request to choose the method of your request.



Methods	Description/Process
Complete with applicant	Use if the applicant is with you and can enter their own details.
Email applicant	An email request will be sent to the applicant to complete their details. You can see if the applicant has completed their form from your dashboard.
Complete on applicant's behalf	Use if you have obtained permission (you may have to provide evidence of this if asked) to enter the applicant's details on their behalf.

For all application types you must enter the following:

Third party details (Details for user's organisation).

Field name	Description		
Company	Third party name. Pre-populated from the registration details entered by your administrator. Not editable.		
Contact name	Name of the contact for the request being created. Prepopulated from Registration details. Not editable.		
Site	Site name of the user. Pre-populated from registration details. Not editable if user only has one site. For administrators that belong to more than one site, this field is editable.		
Email address for report	Distribution email for the report.		
Request on behalf of	Name of applicant who the request is being made for.		
My Reference	Reference the third party wants on the record (third parties own reference number).		
Type of report	Type of report being requested: • All convictions (default) • Traffic convictions only		

Applicant's name and email address

Field name	Description
Applicant name	Name of applicant the request is being made for.
Applicant email	Email address of the applicant. Mandatory if CCH request method selected is Email applicant .

2.1 Complete on applicant's behalf

After entering third party details and applicant name and email address:

1. Complete the applicant details fields.

2. Accept declaration I accept this declaration to complete the application and submit the CCH request.



Ensure you have reviewed all the information you have entered before accepting and selecting **Complete**. Once you have selected **Complete** you will no longer be able to amend any information.

3. Select complete to finalise the request.

Note: Selecting will remove all the information you have entered, and you will be sent back to your dashboard.

2.2 Email applicant

After entering the third party and applicant details:

Select Next

Notes:

- An email will be sent to the applicant's email address entered in the first step with a link to allow them to complete their own details. You will be notified when they have completed their details for you to finalise the request. The status of the request on your dashboard is **Link sent.**
- When the applicant has completed entering their details, the status of the request on your dashboard will be **Awaiting finalisation**.
- After 15 days, the request will expire, and you will have to create a new request


2.3 Complete with the applicant

After entering third party and applicant details:

- 1. A message will display to transfer the completion of the applicant details to the applicant.
- 2. The applicant must select on the Application Authorisation message for them to complete their details.
- 3. When the applicant has completed their details, you will have to log back in. You will be taken to the Finalise Request screen automatically.

3. Finalise request/s

This is the last step to submit your request.




3.1 Finalising a request/s after applicant details entered

You will be sent directly to the **Finalise request** screen after you have completed the Applicant details section.

- 1. Select **Yes** from the dropdown values in the **ID Confirmation** field to confirm you have checked the applicant's ID.
- 2. Select the ID Type you have checked.

Note: You can also amend the following fields if required in the Finalisation screen.

A. **Distribution user –** amend the user that the report will be sent to. Only users that belong to the same site will be displayed on the list.



- B. You can select from the action field to finalise the request at a later stage. The request will be removed from the **Finalise request** screen. The request will be saved in your dashboard.
- 3. Read the acknowledgement information and select to submit the request for processing. If you are not ready to submit the request, select



3.2 Select request/s to finalise from dashboard

You can finalise up to ten requests at a time from the dashboard.

1. From your dashboard select the request/s that you want to finalise.



- 2. Select Finalise selected . You will be sent to the Finalise screen where the request/s you selected will be displayed.
- 3. Confirm ID and select ID type for each request to be finalised.


You can select Remove to finalise the request at a later stage. The request will be removed from the finalise screen and will be saved on your dashboard.

4. Search for request/s

4.1 Search for request/s from your dashboard


You can use filters on all fields on the dashboard to search for specific requests or information.

1. Select the filter icon beside the field to enter your search criteria and select



4.2 Search for request/s from your history

Your History page contains all the requests that have been submitted and those that have either expired or been cancelled in the last 90 days.



4.2.1 History tab details

The History tab contains the following details:

Field	Description
Request ID	A unique request identifier that will be displayed once the request has been successfully submitted for processing.
Applicant name	Applicant name entered from the third-party details screen.
Date finalised	Date when the request was finalised.
My Reference	Organisation's own reference used for a request. This is the information entered in the My Reference field on the third-party details screen.
Applicant email	Applicant's email address.
Requested by	User that initiated the request.
Status	Status of the request. This field can have the following values:
	Link expired – The link in an email sent to the applicant is only valid for 15 days. Once expired the request will be removed from the dashboard and moved to history with "Link expired" status.
	Request cancelled – Status displayed when the requestor or the applicant cancels a request.
	Request submitted – Status displayed for requests that have been finalised and submitted for processing.
	Request expired – Status of a request that has not been finalised or actioned after 15 days. The request will be removed from the dashboard and moved to the history.
	Bulk request submitted – Status of bulk upload requests submitted for processing.
	Request submission pending – Status of request when a request ID is still being generated.

4.2.2 Export your request history

You can export your history data into an excel spreadsheet by selecting from your History screen. If you have filters, only the filtered information will be exported. To export all your requests, make sure you select first.

5. Bulk upload

The bulk upload functionality allows users to upload requests in bulk using an .xml file. This is not a standard feature of the service as it will only be useful to third parties that have the ability to create .xml files.

5.1 Your dashboard with bulk upload


A bulk upload icon will appear beside your Dashboard, Create request, and History options.



5.2 Send a request by bulk upload



1. From your dashboard select Bulk upload Bulk upload



6. Payment

If your payment method is debit or credit card you will be directed to the secure Payment Gateway to make payment.

If your payment method is by invoice, you will receive these monthly.

7. Identification requirements

Third party's obligations regarding ID check.

Third parties are no longer required to provide copy of applicant's ID to the Ministry of Justice using the new service. However, you (Third parties) will be required to verify the information provided in the application against the identification document provided. You can ask the applicant to email you a copy of ID and match the information. Please note you are required to keep this copy of ID for a period of 90 days and securely dispose of it after that.

What to check

During ID check you must ensure an acceptable type of ID is provided. The Following types of identification are accepted:

- NZ or Overseas Passport
- NZ driving license or
- NZ firearms license.

Please note overseas driving license, 18+ cards are not acceptable form of ID.

You must also ensure:

- Information provided in application matches the ID provided such as name, DOB, place of birth and any other names applicant may have.
- ID is not cancelled/ defaced.
- ID is not expired. Please note overseas ID's must be current and NZ ID's can be accepted within 2 years of expiry date.

What if applicant does not have an ID

If the applicant does not have an acceptable form of ID, then they can provide you with either a statutory declaration or proof of identity form. Please note in this case you will be required to ensure:

- Statutory declaration must be signed by an authorized person such as: Justice of Peace, Court Registrar or Solicitor.
- If applicant provided you with a proof of identity form where someone else is vouching their identity ensure:
 - Person who vouched applicant's identity must not be their relative
 - Must not be living at same address

- Must be 18 years of age or over
- Must have known applicant for more than 12 months

These forms will be available on the website of the Ministry of Justice once the new service is live.
