REPORT ON OVERSEAS TRAVEL: UNITED STATES OF AMERICA, 11 APRIL 2019 – 15 APRIL 2019

Proposal

1. I recommend that Cabinet notes this report on my travel to the United States from Thursday 11 April 2019 to Monday 15 April 2019, in order to represent New Zealand at the Financial Action Task Force (FATF) Ministerial Meeting.

Report

- **2.** The purpose of the travel was represent New Zealand at the FATF meeting.
- **3.** At the meeting, Ministers agreed:
 - 3.1. an open-ended Mandate for the FATF and its role leading global action to counter money laundering, terrorist financing and the financing of proliferation of weapons of mass destruction. The adoption of an openended mandate, on the 30th anniversary of the FATF, reflects the fact that these threats are enduring concerns for the integrity of the financial system, and that a sustained political commitment to fight money laundering, terrorist financing, and proliferation financing is required;
 - 3.2. to greater ministerial engagement and support for FATF through regular and more frequent ministerial-level meetings, and by extending the term of the FATF Presidency, and by agreeing to a new funding model for the organisation. FATF's new mandate recognises the need for FATF to continue to lead decisive, co-ordinated and effective global action to counter the threats of the abuse of the financial system by criminals and terrorists, and strengthens its capacity to respond to these threats that all countries face;
 - 3.3. to increase Ministerial meeting frequency to biennially, instead of decennially as has been the case for the lifetime of the FATF.

- There was strong interest from other attending jurisdictions in hearing New Zealand's perspectives, following the horrific terrorist attack in Christchurch on 15 March 2019. US Attorney-General William Barr made time in his diary to see me at short notice, as did several of President Donald Trump's senior staff at the White House.

 - 5.4. Jörg Kukies, Deputy Minister of Finance for Germany;
 - 5.5. Siv Jensen, Minister of Finance for Norway.
