- The fee for filing this application (\$75 if you are adding a class of business)
- A completed company officer form for every officer of the company (a company officer is a director, CEO or person occupying an equivalent position), if you are applying to add a class of business. One company officer form is included as part of this application form. ie: If you are the sole director of your company and have not appointed a Chief Executive Officer, you are not required to complete an additional company officer form.

- You can fill in this form electronically. If you do, you must print, sign, and submit it to the Authority.
- You can also print and fill in this form by hand. Use a black pen or blue pen, and print clearly IN CAPITALS.
- Answer every question on the form unless the instructions tell you otherwise
