# ALCOHOL REGULATORY AND LICENSING AUTHORITY PRACTICE DIRECTIONS AND STATEMENTS PURSUANT TO SECTIONS 172 AND 176 OF THE SALE AND SUPPLY OF ALCOHOL ACT 2012

To: Secretaries

**District Licensing Committees** 

Section 172 of the Sale and Supply of Alcohol Act 2012 provides:

172 Licensing authority may issue practice directions

For the purpose of ensuring that the application and administration of this Act is consistent, the licensing authority may from time to time issue, for the guidance of licensing committees, any directions, notes, guidelines, or suggestions (not being inconsistent with this Act) that the licensing authority considers necessary or desirable.

Section 176 of the Sale and Supply of Alcohol Act 2012 provides:

- 176 Licensing authority may give statements to licensing committees
- (1) The licensing authority may give licensing committees statements setting out its views on
  - (a) the general administration of this Act; or
  - (b) the policies to be followed in the administration of this Act or any provisions of it; or
  - (c) any information obtained by the authority from any inquiry held by it or from any other source.
- (2) A statement must not relate to a matter that may be a ground for an appeal against a decision of a licensing committee.
- (3) In performing its functions under this Act, a licensing committee must observe every statement issued under this section.

This is the second such practice direction and statement issued since the Act came into force on 19 December 2012.

#### 1. MONTHLY RETURN

- 1.1 The licensing authority requires that a Monthly Return be submitted to it by all territorial authorities.
- 1.2 The following information is to be included in the Monthly Return:
  - (a) The number and type of on-licence applications received, and their fee categories
  - (b) The number and type of off-licence applications received, and their fee categories
  - (c) The number and type of club licence applications received, and their fee categories
  - (d) The total fee for licences paid to the licensing authority, by fee category
  - (e) The number and type of managers' certificate applications received
  - (f) The total fee for managers' certificates paid to the licensing authority

- (g) The number of special licence applications received, and their class category
- (h) The number of temporary authority applications received
- (i) The number of permanent club charter payments received
- 1.3 The template to be used for the Monthly Return is attached.
- 1.4 A Monthly Return must be received by the licensing authority, along with the fees due, by the end of the month following the month of the return. If no applications were received in a particular month, a nil return must be provided.
